What is the Grace Community Church Foundation?

The Foundation is an endowment or 'savings account' that provides funding to improve the church. Since its creation in 1977, the general nature of The Foundation has been to promote the religious, charitable and Christian purpose of Grace Community Church. In so doing, The Foundation seeks gifts of money and property to act as custodian of funds, securities, investments and property belonging to or held for the benefit of the Church.

The earnings are used for the benefit of the Church.

What does the Foundation do to help Grace Community Church?

The earnings from the General Fund are used for repair/upkeep of the Church in the form of Capital Improvements. From 1987 to the end of 2016, The Foundation provided approximately \$962,161 to the Church for such items as:

- Roof repairs, Steeple repairs
- Painting & repairs to the buildings
- AC replacements and repairs
- Remodeling/upgrades of different rooms
- Computer and technology improvements

Who can join The Foundation and what is the starting donation?

The Foundation seeks new members who make a donation of \$2,500 or more over the course of 24 months. Donations of all sizes are welcome especially planned giving. We need contributions and legacy giving to grow the fund. Ideally, donations are never spent –only the interest and dividends generated from the principal are used.



ENRICHMENT

Since 2005, the Foundation contributed a total of \$880,319 toward the construction of the Enrichment Center.

Can the Foundation help with planned giving legacy?

How are the Ippolite and Perry funds handled by the Foundation?

During the years of 1987 through 2016, students have been provided scholarships totaling approximately \$558,451 from two legacy donations:

- The Ippolite Fund is designated for scholarships to students studying the Christian Ministry and in accredited medical schools.
- The Perry Fund is designated for advanced degree scholarships.
